

AKC Lifetime OTCH Points for Airedales

The Obedience Trial Champion (OTCH) title is the highest obedience title offered by the American Kennel Club that can be earned competing in obedience trials. Before a dog and handler can begin to meet the requirements of the OTCH title, they must first earn the Utility Dog (UD) title.

The requirements for the OTCH title are that the dog accumulates 100 points and three first places. One first place must come from the Open B class with at least six dogs in competition, one from the Utility B class with at least three dogs in competition and the third can come from either class with the required minimum number of dogs in competition. Each of these wins must be won under three different judges and only one of the first places may have been won at a specialty.

Points are earned by placing first, second, third or fourth in the Open B or Utility B class according to the schedule of points approved by the AKC Board of Directors. The point schedule is based on the number of dogs competing in the class the placement is won.

Only two Airedale's have earned the OTCH title. Ch. OTCH Caleb Acres Aireham Spice, UDX2, owned by Mary Law, earned the title on October 6, 2005. On October 22, 2010, Ch OTCH Brisline Plumperfect Unforgettable, UDX 6, OM6, RA owned by Suzanne Tharpe and Georgia McRae finished her OTCH title.
